

Sir/Madam,


This has reference to your request dated 25.06.2014 and subsequent inspection conducted by the Board on the above subject.

In this connection, I am directed to convey the approval of the Competent Authority of the Board for grant of Composite Provisional Affiliation for Secondary School Examination of the Board reaffiliated for a period of three years w.e.f. 01.04.2014 to 31.03.2017 on the basis of the restoration of the recognition by the Directorate of Education, Govt. of NCT, Delhi with permission for registration of its class-IX and X students to appear in Board's AISSE, 2016 subject to verification of school record and eligibility and genuineness of the students by the Regional Officer, CBSE, Delhi.

The above sanction is subject to fulfillment of following conditions:-

1. The affiliation Code Number allotted to your school is 2730386. This may please be noted and quoted for any further correspondence with the Board.
2. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X vide Circular No. 39/20-09-2009 dated 20.09.2009 in the school.
3. The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.
4. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State / UT Govt from time to time.
5. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under :-

6. The school will provide well equipped Laboratories, Library and other facilities as per norms of the Board. The relevant books to the academic level of students to be made available in the library and would keep at least 05 books per student subject to a minimum of 1500 books excluding text books.
7. The school will also abide itself by the conditions of affiliation already prescribed by the State Government



8. As per Affiliation Bye-laws the optimum strength of a section should not exceed more than 40 students.
9. School should have at least one adequately equipped computer lab with a minimum of 10 computers and would ensure computer student ratio of 1:20 at least. Proper software along with facility of Broad Band connectivity with the feature of 'internet always on' from any service provider to be ensured.
10. The section teacher ratio of 1:1.5 is to be maintained to teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
11. The school and its records shall be opened for inspection by an officer/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.
12. The school will strictly adhere with all rules regarding safety of students including Fire fighting and Transportation, etc. Further, school will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and girls separately in proportion to the number of students.
13. 5-6 names of persons not below the rank of Principal of Sr. Secondary School affiliated with the Board be recommended so that two of them may be approved by the Board as its nominee in the School Managing Committee. Of these 2-3 may be Principal of KV/JNV.
14. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws.
15. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared in the name of school, as per rules. A copy each of the Statements of Accounts should be sent to the Board every year.
16. It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.
17. The Board would not allow any transfer of property/sale of school by one society/ Management/ Trust to another Society/Management/Trust through agreement/sale deed and the school shall not be closed down in the same premises. In case such transaction is effected explicitly or implicitly the Board shall withdraw its affiliation with immediate effect.
18. The school should not start Class XI/XII without written approval of the Board. The Board shall not be responsible for any consequences in case class XI/XII is started without following the Affiliation Bye Laws and obtaining the prior approval of the Board.
19. The school will apply for further Extension of Provisional Affiliation 'on online' through [www.cbseaff.nic.in](http://www.cbseaff.nic.in) with the prescribed fee of Rs. 25,000/- and other essential documents before 30<sup>th</sup> June of the preceding year before the expiry of the date of provisional affiliation otherwise penalty @ Rs 10,000/- p.m. subject to maximum Rs 50,000/- will be charged for late execution of application.
20. The school will open CBSE pattern classes IX w.e.f. 01.04.2014. Accordingly, 1<sup>st</sup> Batch of class X of the school will be appeared at the Board's Examination to be held in the year 2016.
21. School will provide physical facilities as per norms of the Board. The facilities reported at the time of last inspection are as given under:-

24. Special conditions to be complied within three months positively failing which the school is liable for

action:-

- a) It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.
- b) Every school should organize at least one week training programme for teachers every year in association with any teacher training institute recognized by the State or Central Government or by any agency identified by the Board.
- c) Every institute will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and girls separately in proportion to the number of students

- d) Renewed Certificate from the concerned Govt. Authorities of the area relating to sanitary conditions of the school, availability of safe drinking water and fire safety arrangements of the school may be obtained and submitted at the earliest.
- e) The school is required to reconstitute the School Managing Committee as per the provisions of Affiliation Bye-Laws of the Board by including two Board's nominees in it. In this regard a panel of five Principals (inclusive of at least 2-3 Principals from nearby JNV/KV) be forwarded.
- f) The school is required to submit recognition of the school for classes I to V from the Directorate of Education, Government of National Capital Territory of Delhi, Delhi.
- g) The School is having teachers on contractual basis; therefore the school is required to appoint only qualified and trained teaching staff on regular basis. Besides teachers should be given prescribed pay scales alongwith DA and other admissible allowances at least at par with the corresponding category of teachers in the Govt. of NCT of Delhi or as per provisions of 6<sup>th</sup> Pay Commission through ECS. A copy of latest staff statement showing details of all the staff i.e. Name, Designation, DOB, Educational Qualification, Experience, Pay scales etc. and latest acquaintance roll showing details of salary being given to the staff, mode of payment of salary with proper deduction of EPF etc. be furnished after doing needful. The same can be checked and verified by the Board at any time.
- h) The school is required to appoint more trained and qualified teachers (at least 08 teachers) to maintain section teacher ratio as per norms of the Board and furnish a fresh staff statement accordingly.
- i) The school library needs to be enriched with more books, periodicals etc..
- j) The salary should be paid through Electronic Clearing Service (ECS) from the date of first appointment of the teachers on probation and should be transferred in the individual accounts of staff through ECS. A Certificate from the Bankers to the effect that the salaries are credited in the personal accounts of the staff members through ECS with documentary proof be submitted at the earliest.
- k) The school should have adequate infrastructure including building playground etc. as per Affiliation Bye-Laws of the Board.

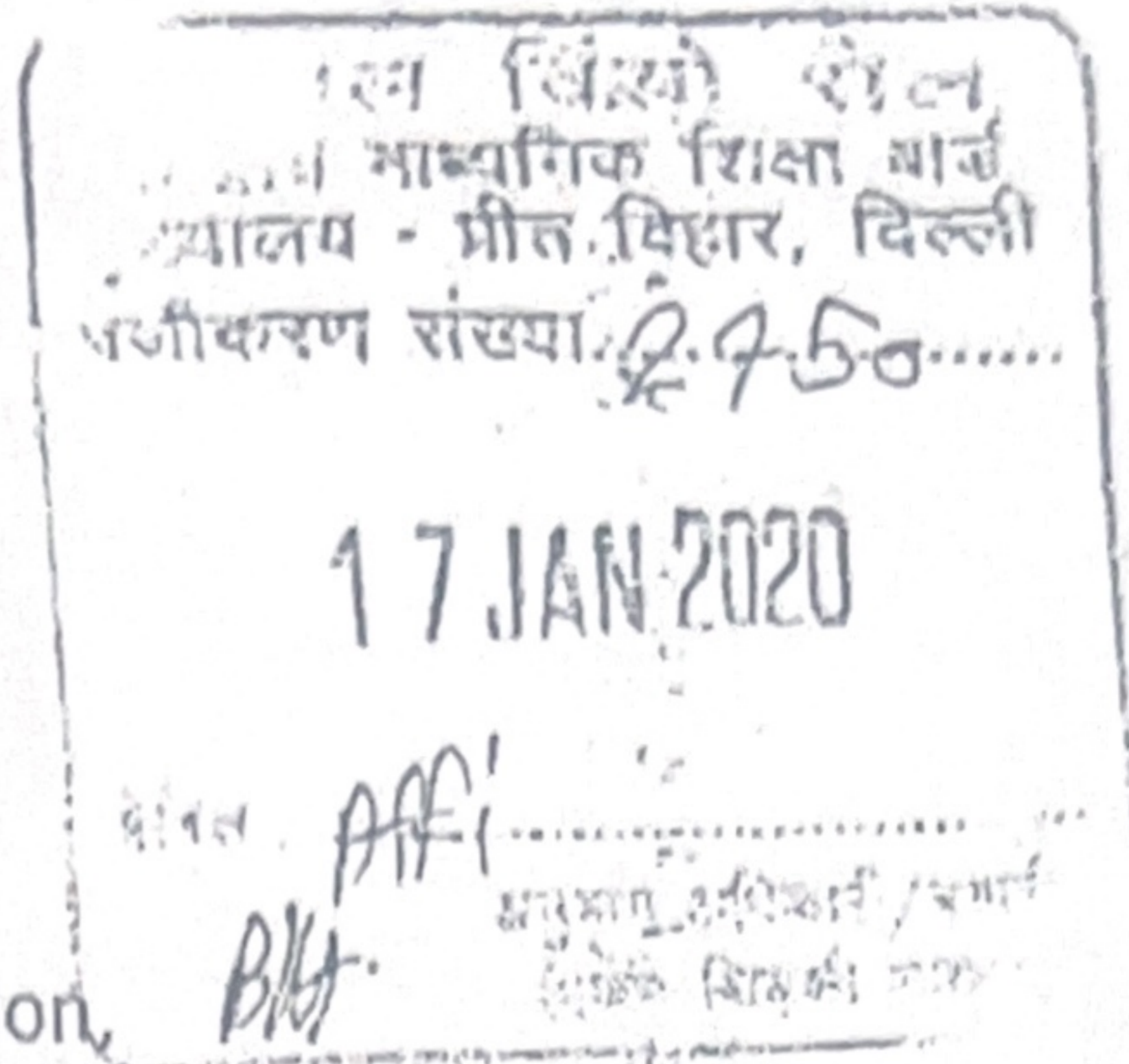


